# Cross-examination by Wahab Khan for A2, 7, 10 & 13

1. I am traveling in local trains since last more than 10 years. I have experience about the crowd in the Mumbai local trains. I cannot say whether I had boarded 645 Down Virar fast train of 1807 hours which was late by 5 minutes. I cannot say whether I was standing in the space in between the two doors. It is true that sometimes it is heard in Virar fast trains that passengers object to persons who have boarded it for getting down at Dadar or Bandra. I do not remember

exactly whether I was standing in the gangway near the partition. The portion where I stood was crowded. It became more crowded at Dadar Station. I do not remember whether some passengers got down and some boarded at Dadar Station. It is not true that I did not suffer serious injuries. Police did not show me any photographs of dead persons and I did not identify anyone. I had not stated so to the police. (Witness is confronted with the relevant portion from his statement. Hence, it is marked as 'A'). I cannot assign any reason why it is so written in my statement. I did not make any complaint about the blasts. I had not stated to the police that some unknown person had caused the blasts with the intention to create terror and therefore, I have complaint against him. (Witness is confronted with the relevant portion from his statement. Hence, it is marked as 'B'). I cannot assign any reason why it is so written in my statement. I cannot tell whether the other persons in the bogie were more or less injured than me.

2. A double fast train going towards Churchgate does not halt at stations in between Mumbai Central and Churchgate. I do not know whether there is more frequency of double fast trains after 5.00 p.m. I

cannot say whether the fast train from Churchgate to Virar halts at platform no.3 at Mumbai Central.

that it was difficult for passengers at the next station Dadar to enter in the bogie. It is true that at the time of the blasts I was standing in the gangway. I got down from the train after the blasts. Other passengers also got down.
