Examination-in-chief by SPP Chimalkar for the State

I was attached to Borivali Police Station in 2006 as police naik.

I was deputed to the ATS on 27/06/06. I came on duty on 27/10/06 at 9.00 a.m. I received a message that I am called by ACP Patil to the ATS office at Bhoiwada. Accordingly I went there and met him. He gave me a forwarding letter and its office copy and fifteen sealed packets and told me to reach them to the office of the FSL, Kalina. I then went to my office at Kalachowki, made a station diary entry and then went to the FSL, office at Kalina. I handed over the forwarding letters and the sealed packets to the receiving clerk, he gave an acknowledgment on the office copy and returned it to me. Office copy

of the forwarding letter now shown to me is the same. It bears the acknowledgment of the receiving clerk. (It is marked as **Ext. 1596**). I returned to my office at Kalachowki, made station diary entry and then went to the ATS office at Bhoiwada and handed over the office copy to ACP Patil. He took my statement.

2. I will be able to identify those fifteen packets. The labels and the transparent plastic bags Arts. 345A, 345, 346A, 346D, 347A, 347C, 348A, 348C, 349A, 349D, 350A, 350D, 351A, 351C, 352A, 352C, 353A, 353D, 354A, 354C, 355A, 355C, 356A, 356C, 357A, 357C, 358A, 358C, 359A and 359D now shown to me are the same.

Cross-examination by Adv P. L. Shetty for A3, 8, 9, 11 and 12 and h/f Rasal for A1 & 4 to 6

3. I was attached to the Chandan Chowki office of the ATS. Sr. PI Sunil Deshmukh, PI Tonpi and API Kandarkar were attached to that office. All the packets were transparent plastic bags. I do not remember whether the labels were affixed outside the plastic bags or placed inside them. I cannot say whether the Art-353D was the same plastic bag. It is true that the backside of the label Art-353A does not show gum markings. I cannot say whether on seeing the label Art-

353A, I can say that it was a pasted label. Same things as stated by me above can be said about all the remaining labels and plastic bags. I do not now remember whether the labels were pasted outside the plastic bags or were put inside them. I cannot say whether these are the same plastic bags that I had taken and whether some other plastic bags have been substituted. I do not remember in what condition the packets were, when they were given to me.

4. I have taken articles to the FSL, Kalina about 10-15 times. I cannot tell the dates and the timings of reaching the articles on the other occasions and recording my statement at that time, because of lapse of time. I had read a copy of my statement two days before at my house. I told the dates and all details on the basis of the statement. I had taken a copy of my statement on 27/10/06 when it was recorded. It is not true that the ATS officers gave me my statement two days before and tutored me to give evidence.

- I was the only one from my police station to assist the ATS in the investigation of this case. Twelve officers were deputed to the ATS from all over the Mumbai. I remember that HC Vinayak Nanaji Gaikwad from Motor Transport, PN Sakharam Desai from Mantralaya Security, one PN Joshi had been deputed. I do not remember the names of the others. I cannot say which police stations were helping the ATS.
- 6. I was at Chandan Chowki on 22 and 23/10/06. (Learned advocate asks the accused no.7 to stand up and points him to the witness). I had seen this accused in the Chandan Chowki on these days. I do not remember whether he had marks of injuries on his person. Chandan Chowki did not have muddemal property room. It was at Bhoiwada. I do not know how many brass seals the ATS had, whether Chandan Chowki had its own brass seal and whether there was only one seal for the entire ATS of Mumbai. I do not remember whether the ATS brass seal was called to the Chandan Chowki unit from any other ATS office. I had not carried the seal of the ATS to the Chandan Chowki from anywhere. I was attached to the ATS for 10 months. I did not come to know whether a permanent seal was

allotted to the Chandan Chowki Unit or whether seal was called from outside. Station diary was maintained in our unit. I do not remember having seen or heard anyone making station diary entry about seal. I do not remember about having seen any article being sealed in our unit. It is not true that I did not take any article to the FSL and that I deposed falsely.
