EXAMINATION-IN-CHIEF BY SPP RAJA THAKARE FOR THE STATE.

1. I am attached to Police Station, Vasai Road since four months as constable. Before that I was attached to Bandra Railway Station from 2003 to 2010. C.R.nos. 86 and 87 of 2006 were registered in the police station concerning the bomb blasts in between Bandra and Khar and the other between Khar and Santacruz. On 13.07.2006 I was on duty from 9.00 am to 9.00 pm. Senior PI called me and gave three sealed parcels and directed me to reach them to the forensic science laboratory at Kalina. Two parcels were of CR.no.86 and one was of CR.no.87. I was given the three parcels, one letter and its office copy. I went

to Kalina and handed over the three parcels and the letter and obtained the acknowledgment from the Forensic Science Laboratory at Kalina. I will be able to identify the office copy of that letter. The office copies of the two letters, one of CR.86 and one of CR.87 in two pages each, are the same. They bear the acknowledgment of the office of FSL, Kalina along with their stamps. {They are marked as **Ext 656 (1 and 2)** and **Ext 657 (1 and 2)** respectively}. I will be able to identify the wrappers of the parcels. (Witness is shown Arts. 113B, 114A and 115B). The wrappers now shown to me are the same that I had taken. My statement was recorded.

Cross-examination by Adv Rasal for A/1 and 4 to 6 .

2. My statement was recorded on 13/7/2006 at about 5.30 pm by PSI Salvi. Before this date I had gone to the office of the FSL. The receiving clerk at the office of the FSL asks our buckle number and makes entry about it. It is true that my buckle number is not mentioned on the acknowledgment of the FSL on both the letters. The buckle number is entered in their register. It is not true that I had not personally gone and given the parcels in the office of the FSL.

Cross-examination by Adv P. L. Shetty for A/3, 8, 9, 11 and 12

3. PSI Salvi took my statement and PI Kadri also took my statement. I had given the originals of both the pages of Ext. 656 and Ext. 657 to the FSL

office. I do not know who wrote the handwritten words in front of the word 'sandarbha' in Ext.656(2) and when they were written.

It is true Ext. 656 (2) is a xerox copy. The words on the lac seals on the wrappers Arts.113B, 114A and 115B cannot be read. I cannot say who put the stamp of the seal on the forwarding letters and when they were put.

Cross-examination by Adv.Mr.Shetty h/f. Wahab Khan for A/2, 7, 10 & 13
