EXAMINATION-IN-CHIEF BY SPP RAJA THAKARE FOR THE STATE.

1. I was attached to Mumbai Central Railway Police Station in the year 2006. Even now I am attached there. On 13/07/06 I was on duty from 9.00 a.m to 9.00 p.m. PI Rathod ordered me and HC Jadhav B.N. 731 to take the sealed articles in the above CR numbers to the office of the FSL, Kalina, Mumbai. I was given four sealed packets, a letter and its office copy pertaining to CR No. 77/06 and HC Jadhav was given five sealed

packets, a letter and its office copy pertaining to CR No. 78/06. We took entry in the station diary and went to the office of the FSL, Kalina and handed over the parcels to the receiving clerk and obtained acknowledgment on the office copies of the letters. Then we returned back and gave the office copies of the letters to the Sr. Pl. I will be able to identity the office copies of the letters. The office copy of the letter now shown to me is the same. It bears the signature of Pl Rathod and the acknowledgment of the FSL, Kalina. (It is marked as **Ext.660**). I will be able to identify the outer envelopes that I had taken to the FSL. My statement was recorded.

Cross-examination by Adv Rasal for A/1 and 4 to 6

 I do not remember the exact time when I reached the office of the FSL and delivered the parcels. It is true that my buckle number is not mentioned on the letter Ext.660. I cannot state at what time my statement was recorded.

Cross-examination by Adv P. L. Shetty for A/3, 8, 9, 11 and 12

3. The letter and the parcels were given to me at about 10.00 or 10.15 a.m. on 13/07/06. I did not initial any letter that was given to me. It is true that it is not mentioned in the letter that the parcels were

given in my possession for being reached to the office of the FSL. PI Rathod gave me the letter and I took the parcels from the muddemal clerk HC-Karande, B. No. 833. The parcels were on his table. PI Rathod gave me the letter from his room. It is true that the letter is dated 12/07/06. The letter bears the signature of PI Rathod.
