EXAMINATION-IN-CHIEF BY SPP RAJA THAKARE FOR THE STATE.

1. I was attached to the Bandra Railway Police Station from 2004.

I was on general duty on 17/08/06. General duty ASI Gophane called me and told me to take two sealed packets to the FSL, Kalina. He gave me two letters along with their office copies and I collected two khaki sealed envelopes from the muddemal in-charge. They were in connection with CR No. 86/06 and 87/06 of Bandra Railway Police Station. I took an entry in the station diary at 11.00 a.m. and went to the FSL at Kalina. I handed over the letters and the envelopes to the

receiving clerk and obtained his signatures and stamp on the office copies of the letter. They are the same now shown to me. They bear the signatures and the stamp of the receiving clerk of the FSL, Kalina. (They are marked as **Ext.888 (1 &2) and 889 (1 & 2)**). Then I returned back at about 4.30 p.m. and took station diary entry.

2. Declined.

Cross-examination by Adv P. L. Shetty for A3, 8, 9, 11 and 12

3. I was told about taking the envelopes on 17/08/06 and not before that. I saw the letters and the envelopes only on that day. I cannot say who wrote the letters. The outward clerk put the outward numbers on the letters. I do not remember his name. It is true that the dates at the end of the letters Exts.888 (1) and 889 (1) are 31/07/06.

Cross-examination by Adv Wahab Khan for A2, 7, 10 & 13

4. It is true that other than this case I have taken articles to the FSL once or twice. I do not now remember the dates on which I had taken the articles of the other cases to the FSL. I have read my statement fifteen days before in the police station. On that basis I

stated about the dates. An ATS officer gave me a copy of my statement one and a half months before. I had requested him to give the copy. I do not remember the name of that ATS officer.
