# **EXAMINATION-IN-CHIEF BY SPP RAJA THAKARE FOR THE STATE.**

1. I was attached to Mumbai Central Railway Police Station in 2006. I was helping in the investigation in the railway bomb blasts that had taken place on 11/07/06. I had taken articles in connection with this crime to the FSL on 13/08/06. It was a sealed carton and Sr. PI Rathod told me to take it carefully as there were bottles in it. He had directed me to take the carton from the ATS office, Kalachowki, I took the carton from there and deposited it with the office of the FSL along forwarding with letter. The receiving clerk gave acknowledgment on the office copy of the letter. It is the same now shown to me, it bears the acknowledgment of the receiving clerk and my buckle number. (It is marked as **Ext.908** as the learned advocates for the accused consent. The CA report along with it is received in evidence under section 293 of the Code of Criminal Procedure, hence it is marked as **Ext.909**). I had made an entry in the muddemal register and the station diaries when I left and returned. My statement was recorded accordingly.

# Cross-examination by Adv Wahab Khan for A2, 7, 10 & 13

2. PI Rathod recorded my statement at Bhoiwada on a laptop. I now again say that it was a computer. I did not produce copy of station diary or muddemal register before him. I did not tell him station diary entry numbers. I cannot say when PI Rathod was deputed to the ATS. I was also deputed to the ATS after about 4-5 days. I do not know where the head office of the ATS was. I worked in the ATS for about six months. I do not know whether the muddemal property room of the Crime Branch is in the commissioner office. I do not know where the muddemal room of the ATS is. I had not seen the seal of the ATS when I joined. I had seen it during the period of my joining the ATS and upto 13/08/06. I had not used it many times during this period. I do not remember whether in my presence the

seals of other police stations used to be called and used. It is not true that upto 13/08/06 the ATS was not given any seal. I had seen it with PI Rathod. I did not see him putting the seal on the letter Ext.908. It is not true that I deposed falsely.

Cross-examination by Adv h/f Rasal for A/1 and 4 to 6 and Wahab Khan h/f P. L. Shetty for A3, 8, 9, 11 and 12
