 I was attached to Crime Branch of Railway, Bandra Unit in 2006. I collected articles and reports from the FSL, Kalina on 10th and 11/08/06 and deposited them in the Bhoiwada ATS office on the same dates in connection with ML Case No. 344/06 and 358/06 respectively.

Cross-examination by Adv Wahab Khan for A2, 7, 10 & 13

I was on duty in the Crime Branch of Railway, Bandra Unit on 11/08/06 from 9.00 a.m. to 9.00 p.m. I was not given any special duty on that day. PI Rathod was not attached to our unit. He was attached to Mumbai Central Railway Police Station. I was called to the ATS

office at Bhoiwada by telephone. One requires half an hour by taxi from the Bandra Railway Crime Branch Unit to the ATS office at Bhoiwada. One requires one hour by taxi from ATS office, Bhoiwada to FSL, Kalina. I reached the ATS office at 2.00 p.m. I collected letter from PI Rathod. I reached FSL, Kalina at about 3.00 or 3.30 p.m.. Thereafter I returned to the ATS office at Bhoiwada and gave the articles in the custody of PI Rathod. I do not know where the muddemal room of the ATS is in Bhoiwada. PI Rathod did not tell me to deposit the articles in the muddemal room. PI Rathod recorded my statement on laptop. I do not know whose laptop it was. There were other staff members of the ATS in that office when I went there. My statement was recorded at about 7.00-7.30 p.m. I had reached the ATS office at about 7.00 p.m. I was at FSL, Kalina for about two hours. It is not true that I had not collected any articles from the FSL, Kalina and had not brought them to the ATS office. Head office of the ATS was at Kalachowki. I did not go there on that day and did not deposit any article there. No entry was taken in my presence in the station diary or in the muddemal register. My signature was not taken on any register at Bhoiwada. It is not true that I deposed falsely as I am tutored.
